IN CONSIDERATION of being permitted to participate in any Paintball, Reball and/or Airsoft activities including, but not limited to, playing, using the premises of, renting and operating equipment leased, sanctioned and/or operated by the above named vendor, I acknowledge and agree that:

I fully understand and acknowledge that; (a) risks and dangers exist in my use of Paintball, Reball and/or Airsoft equipment and my participation in Paintball, Reball and/or Airsoft activities; (b) my participation in such activities and/or use of such equipment may result in my injury or illness including but not limited to bodily injury, disease strains, fractures, partial and/or total paralysis, eye injury, blindness, heat stroke, heart attack, death or other ailments that could cause serious disability; (c) these risks and dangers may be caused by the negligence of the owners, employees, officers or agents of **LEGACY PAINTBALL PARK**; the negligence of the participants, the negligence of others, accidents, breaches of contract, the forces of nature or other causes.
